- Business handles 6 times from original however more efficient. All felony train prosecutors
- 60% - Work release, pay fees,
- 40% - Hard jail
- Texas Incarcerates more than other states 10/1000
- 1830 - Jails used for hold people before prosecutors
- 1870 - Penitentiary started here in the U.S. Is not working. Expensive flawed by the numbers.
